Levallois, **7 May 2015** --- Alliance Automotive Group, one of the leading distributors of car and HGV parts in France and Europe, is pleased to announce the acquisition of Saint Amand Service France (SASF), a distributor specialising in bodywork parts.

The Saint Amand Service France platform is located in Villebon-sur-Yvette (91) and has two sales offices in Lyon and Toulouse. Its turnover was 20 million Euros in 2014.

This acquisition complements the Group's development strategy in the Crash-Repair market, after the extension of specialised brands Précisium Color and Color Services, leading distributors of painting in France.

Internationally, Alliance Automotive Group is the largest shareholder of Groupauto International.
